REPORT IUC 2005

"Wherever they burn books they will also, in the end burn human beings." (Heinrich Heine, "Almasor", Scene I, written 1820) was our central tenet in course 2005 in Inter University Centre/IUC in Dubrovnik, where on December 6, 1991 library with cca.25.000 books was burnt. Genocide and war crimes in Prijedor (spring 1992) and Srebrenica (July 11, 1995) have happened later. We wanted to teach our students to understand signals of evil and to speak out when the evil happens. (Janja Bec, Course Author)

RESEARCHING WAR CRIMES AND GENOCIDE 1995-2005

Over period of three months, from the beginning of November 1995 to the end of January 1996, in three refugee camps in Slovenia-in Celje, Maribor and Ptuj-I lived and talked to about one hundred refugee women who had lost members of their immediate family (children, grandchildren, husbands, brothers, sisters, mothers, fathers) as victims of war crimes and genocide in Bosnia and Hercegovina in the spring and summer 1992 and in July 1995.

The women come from three regions. The first is Kotor Varos, the villages of Orahova, Cejvani, Vrbanjci, Vecici, Grabovci, Hanifici. The second is Kljuc, Sanski Most and Prijedor, the villages of Prhovo, Gornji Biljani, Hrustovo, Jugovci, Velagici, Pudin Han, Biscani, Trnopolje, Ljubija. The third is Srebrenica and Zepa, the villages of Milacevci, Krusev Dol, Potocari.

I tape-recorded the stories of forty women in the refugee camps and by the end of June 1996 had transcribed ten, without any changes. In summer of 1996 Emir Dragulj started working on the drawings, Aleksandar Tisma had written foreword for Serbian and Richard Goldstone for English language version of my book "The Shattering of the Soul", published in Belgrade 1997 by Helsinki Committee for Human Rights in Serbia and Radio B92. Ales Kurt directed "The Shattering of the Soul" in "Kamerni Theater 55" in Sarajevo 1998.

In Open Society Institute, New York, 1998 and 1999 I have done research about the first war brain-drain in Europe since Second World War, from the territory of ex-Yugoslavia 1994-2000, based on case study about 2431 students who pursued their studies in 29 countries all over the world. These young people left their homes, fleeing from the wars. Most of them (more than 80%) left war zones; 64, 74% were from Bosnia and Hercegovina; 16, 28% were from Kosovo and Macedonia places where the threat of potential war was the highest. In this way, they only continue the tradition of these societies-now economically, politically, morally devastated by wars-of easily parting with the most vital elements of their population. The wars in the former Yugoslavia, which started in 1991, caused the largest exodus of intellectual and cultural elite in Europe since 1945, an exodus which is still continuing.

TEACHING ABUOT WAR CRIMES AND GENOCIDE 2002-2005

In one small kitchen in Sarajevo in spring 2003, we three women from ERMA/European Regional Master in Human Rights and Democracy in Southeast Europe, Center for Interdisciplinary Postgraduate Studies, Universities in Sarajevo and Bologna, my two friends and assistants Ms.Mia Sidran, Ms. Nejra Nuna Cengic and I, we have started one new MA course"War Crimes, Genocide and Memories". We have got support from ERMA directors professors Zdravko Grebo, University of Sarajevo and Stefano Bianchini, University of Bologna. This was the first MA, and until now the only MA course in Southeast Europe with this subject. My greatest "disadvantage" was that I am from aggressor's side, from Vojvodina, (Serbia and Montenegro).

SOME RESULTS

Three years latter, there are some results of this risky and difficult project. My course "War Crimes, Genocide and Memories" is now part of official curricula in European Regional Master's for Human Rights and Democracy in Southeast Europe, University of Bologna and Sarajevo. Number of teaching hours increased from 2 (2002/2003) to 20 (2004/2005) plus IUC course 44. Over the three years long period 100 ERMA and 24 guest students had studied this course.

MA THESES

The first thesis devoted to this subject was written by one of ERMA third generation class 2002/2003 student, Sergio Paini, Italy and two years later three theses of ERMA fifth generation class 2004/2005 students, Azra Smailkadic, Bosnia and Hercegovina, ("Violence against Women: From the Bedroom to the Battlefield"), Barbara Chiarenca, Italy ("Changed Gender Roles in Post-Conflict Society and their Impact on Socio-Economic Status of Women: Case Study: Female Headed Households in post-conflict Srebrenica Region") and Emir Suljagic, Bosnia and Hercegovina ("Community of Murder: Comparing Twentieth Century Genocide").
